II. Minutes from June 10th

III. Spotlight from Gene Seaman/Human Rights Authority

Gene shared information about the Illinois Guardianship and Advocacy Commision. This agency is made up of9 regional Authorities around the state. They investigate alleged violations of the rights of disabled persons, any age birth to death. The person whose rights may have been violated do not need to have a legal disability to qualify for eligibility for help. They do not provide guardianships but will help support achieving guardianships. Gene is the only state employee in the Human Rights division. The HRA is the division that investigates and is assisted by volunteer advocates. There are 9 people on the board that investigate the allegations. 3 of those people are service providers, and the others are members of the community. The HRA is not a enforcement organization. They make suggestions how to solve the situation. The provider has 30 days to respond with how they are going to correct the situation, and if they neglect to remedy the problem, the HRA can make the allegations public, or turn the complaint over to the licensing department in charge of that provider, such as the Dept. of Public Health, ISBE, etc.

IV. FonDuLac Farm Park Report: The family activity was well attended and enjoyed by the EI and PI families. Water bottles and fish crackers were provided to adults and children after their farm park visit. Appreciation for the activity was expressed by many of the families attending.

V. <u>Budget and Binders/Report:</u>

- **a**. Binders were distributed in Peoria, Tazewell and Woodford Counties. Appreciation was expressed by many of the receiving medical facilities.
- b. The next round of binders have been purchased and will be assembled for area daycare centers.
- **d.** LIC monies for 2015 have been spent on postage, colored ink, paper, 20 binders and on radio spots to advertise the CFC/LIC services. Gary is waiting to air those radio spots until after the CFC's financial situation is settled. The CFC/LIC does not know how much money we may have in the FY2016.

VI. LIC 16/Manager's Report/Gary Reed

a. Jim R. was unable to attend but shared some "State of the State" notes through Gary. The state is deadlocked and no movement has occurred. There is an unprecendented gulf between our Governor and the Speaker of the House. Jim also noted that only 20% of state agencies are not funded at this time, unfortunately the CFC is part of that 20%. The CFC is currently operating under a line of credit that was obtained by Easter Seals. When that line of credit runs out, the CFC may have to go on another furlough until further funding becomes available. It is not too late to **ADVOCATE!** At this time, the CFC is open, and all

referrals should go through the CFC office. Everyone will be notified if the office does shut down again.

b. Referrals: June 2014-94 July 2014-88 June 2015-95 July 2015-84

147 cases were closed in June 2015, which is a larger than normal # of closures, most were due to the child aging out of the program.

c. The CFC has discontinued the use of the U of I Consultative services for medical case reviews. Mary Beth A. and Tina A. have moved to new positions. Malinda Radloff is the new Consultative Physician.

VII. <u>Committees: Group Discussion & Reports:</u>

- **a.** Transition Committee-update current flow chart to ensure it is current and create a more detailed, local flow chart for local options.
- **b.** Provider Recruitment-make a list of providers that are not currently in Early Intervention, contact them to see if they would be willing to give EI a try. Use the list of agencies so new graduates can look at the area providers. Locate neutral sites for providers to work in rather than homes. Contact agencies that hire new interns, introduce the interns to EI services.
- **c.** Public Awareness-use Facebook, keep it current. Suggestions made on what could go on the LIC Facebook page. Developmental milestone posters distributed to Health Depts., WIC offices, food pantry's, etc.
- **d.** Parent Group-parent café, this fall, with a topic of Transitions after 0-3. Marsha will contact area libraries to see if we can use some of their space to meet.
