Re: Early Intervention (EI) Weekly Update

As mentioned in prior updates, the Bureau has been working with a diverse group of stakeholders to anticipate needs and guide responses to the challenges presented by the pandemic. The Reopen Illinois EI Workgroup includes providers, family members, Illinois Interagency Council on Early Intervention members, professional association representatives, physicians, Child & Family Connections (CFC) managers, service coordinators and advocates. Their perspectives have been invaluable in crafting communications and guidance to the field.

Given the magnitude of work, we have worked to create subgroups to create better, smarter processes and researching during the hybrid services modalities. For instance, there have been groups to explore electronic signatures, transition options, services within childcare settings, family communication, system communication, data, CFC supports, and social emotional supports. These groups have helped with:

- identifying a potential system for the collection of electronic signatures on EI consents,
- developing a joint Part B/Part C transition guidance document (currently in approval process),
- determining the parameters for EI services within childcare settings,
- recommending development of, and reviewing, resources for families, e.g. tipsheets, webinars, and <u>FAQs</u>,
- clarifying informational needs, participating in webinars, and suggesting items for inclusion in weekly updates,
- proposing items and systems for data collection,
- enhancing tools for CFC use, and
- determining options for supporting system stakeholders' social emotional well-being.

The Re-Open Illinois EI workgroup continues to meet weekly to review data, receive subgroup updates on identified priorities, and respond to emerging needs.

We have received questions about how stakeholders can monitor changing conditions within their respective regions. The <u>Illinois Department of Public Health website</u> continues to be the

best source of information on regional conditions and the activities permitted within each Phase of the Restore Illinois plan.

As discussed last week, the Bureau has received a number of questions about the resuming inperson services (see <u>Guidance</u>). In response, a <u>frequently asked questions document</u> has been developed. Though limited in-person services may now begin, phone consultation and live video visits continue to be the safest methods for providing services at this time.
